

Pro-rated Application Dues

The HRPA ensures that our 24,000 members and students have the most up-to-date tools and the advanced skills to lead our workplaces into the future. We regulate HR professionals in the public interest. Our members and students are held to the province's highest standards, so Ontario workplaces can trust us to help unlock business growth and optimize employee potential. Because the HRPA means better HR.

HRPA's registration year runs from June 1st – May 31st. Dues are pro-rated on a monthly basis, so you only ever pay for the number of months remaining until the next May 31st, at which point you would need to renew to continue your registration. For example: If you join in January 2024, your registration is valid from January to May 2024. You must renew by May 31, 2024, to continue your registration or submit a completed [resignation form](#) if you do not wish to remain part of HRPA.

The first step in the application process is for you to complete the online application, pay your application dues and submit any supporting documentation, if applicable. Your application will then be reviewed by a staff member of the Office of the Registrar – that process usually takes between 5–10 business days. If your application is deemed complete – meaning you have met the Good Character requirement (more on that [here](#)) and all applicable supporting documentation has been received – we will send you a confirmation email and add you to HRPA's [Public Register](#). Practitioner

Practitioner is our main registration class for new applicants. If you are not eligible to join as either a Student or an Allied Professional, this is the class you would apply for – and you can join as a Practitioner even if you are not currently practicing HR.
